All hours mentioned are CET-1.


Participants and accreditation

For registration, please follow these steps:

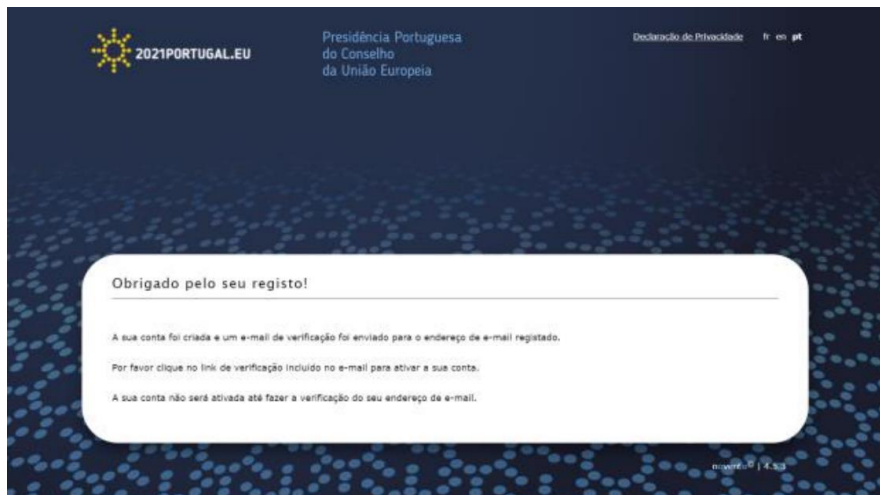

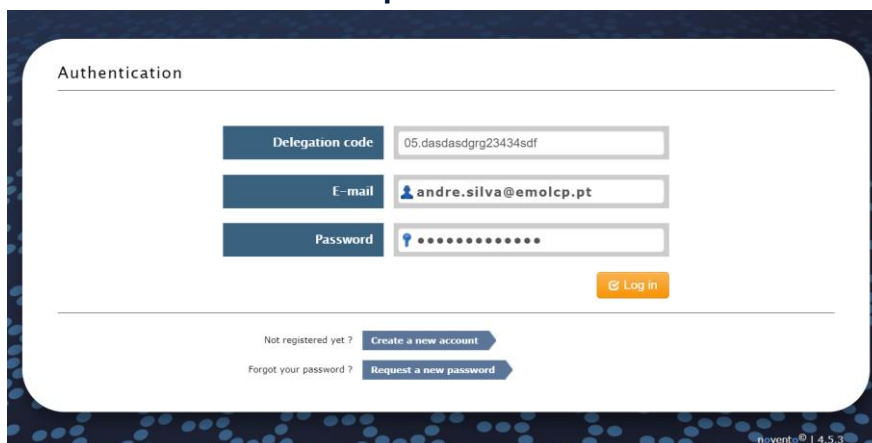


4) In the email received, validate the link in “activate your account”.




5) A delegation code will be requested, which will allow you to access the form to fill, for the Conference.
